To file your return and make a payment:

• mail this form and payment (if required) to the address above.

PART 1 - BUSINESS INFORMATION

PART 2 - FUEL ACTIVITY

Form section for fuel activity including applicable boxes (Amended Return, No Travel Outside of BC, Cancel IFTA Licence), fuel consumption rates table, and tax due/penalty/prior period balance/amount enclosed/refund requested fields.
