## Instructions:

- This certificate may be used **on or after April 1, 2024**, by large industrial operations registered in B.C.'s output-based pricing system (B.C. OBPS).
- Completion of this certificate allows a purchaser to claim an exemption from carbon tax on fuel if:
  - the fuel is for use by a B.C. OBPS regulated operation to produce a regulated product, or by a B.C. OBPS new entrant, and
  - greenhouse gas emissions from the fuel will be attributable to the regulated operation or new entrant.
- If you claim this exemption but use the fuel for a taxable purpose, you must self-assess and pay carbon tax on the fuel at the rate that applies for the period of use. For more information, see Bulletin MFT-CT 006, Self-Assessing Motor Fuel and Carbon Tax.
- You require a six-digit B.C. OBPS Regulated Operation (BORO) ID number to complete this form. You receive this number after registering in the B.C. OBPS program through the Ministry of Environment and Climate Change Strategy. For further guidance, see their

# CERTIFICATE OF EXEMPTION B.C. OUTPUT-BASED PRICING SYSTEM REGISTRANTS

under the Carbon Tax Act

#### **Responsibilities for Sellers and Purchasers:**

**Sellers** – this certificate allows you to collect the information required to substantiate an exemption under the Carbon Tax Act.

Obtain a completed copy of this certificate at or before the time of the sale and keep it in your records to support non-collection of tax on the sale.

If you do not receive a completed copy of this certificate at or before the time of the sale, you must not grant the exemption. Granting the exemption without obtaining a completed copy of this certificate may result in an assessment, penalty and interest.

**Purchasers** – you are responsible for ensuring that you meet all the requirements of the exemption under the Carbon Tax Act.

Complete a copy of this certificate and provide it to the seller at or before the time of the sale.

If you complete the exemption certificate but do not qualify for the exemption, you are responsible for paying the tax as applicable.
